In addition, Alexandre counsels clients on US and international export controls and economic sanctions compliance. He conducts sanctions-related open-source intelligence (OSINT) due diligence research and assists companies in developing and implementing trade compliance policies and procedures.

Originally from Bordeaux, France, Alexandre studied law in France, England, and the US, which give him a strong understanding of the UK and EU legal and regulatory frameworks, including compliance with applicable directives and regulations.
